

TERMS AND CONDITIONS OF RESEARCH SERVICES

Parties to these Terms and Conditions:

- i. Research Analyst: The EB Capital Services Private Limited, a SEBI Registered Research Analyst, holding Registration No. INH000021447, with its registered office located at 46/4, K No437/424/414/661, /3/1114/3,4,5 G B Palya, Bommanahalli (Bangalore), Karnataka, India, Bangalore, Karnataka, 560068, hereinafter referred to as the "Research Analyst" or "RA";

1. Availing The Services:

11. Optional Centralised Fee Collection Mechanism:
